PREPARATION

PLANNING YOUR TRIP

The first session with James will begin early Friday morning, November 13, 2009. We strongly recommend that you plan to arrive in Las Vegas prior to the event on Friday. Here's why:

1. Registration will be open from 8:00pm-9:00pm on Thursday night and then again from 7:00am-8:00am on Friday morning.
2. The event will begin at 8:30am Friday morning.

TRANSPORTATION
